MASSACHUSETTS EMPLOYER HEALTH COALITION **ANNOUNCES NEW STEERING COMMITTEE**

*Employer Coalition Reaffirms Goals and Identifies Potential Pathways to Address Avoidable
Emergency Department Use*

BOSTON – Thursday, April 18, 2019 – Today, the Massachusetts Employer Health Coalition (MEHC), a group of over 25 business organizations focused on driving change in the health care system, announced the creation of its Steering Committee. The Committee is comprised of 19 business and health care leaders from organizations across the Commonwealth, and held its first meeting on March 26, 2019. The objective of the Committee is to issue recommendations regarding interventions that will achieve MEHC’s goal of reducing potentially avoidable emergency department (ED) utilization by 20% through 2020, resulting in potential savings of as much as \$100 million.

The Steering Committee will provide strategic leadership to spearhead the work of MEHC, offer insights into strategy development and implementation from the perspective of member organizations as well as broader stakeholder groups, and act as ambassadors, advocates, and partners for MEHC by offering commitments moving forward.

“Rather than just sitting around a table talking about solutions, we have an opportunity here to be more proactive, and that’s the goal of MEHC and this group,” said Rick Lord, Coalition Co-Chair and President and CEO of Associated Industries of Massachusetts (AIM), during his opening remarks.

At its inaugural meeting, the Steering Committee addressed important topics related to its goals, including care redesign, incentive alignment, and information gathering and sharing. Committee members also shared their perspectives as professionals, consumers, and caregivers, and identified a deeper understanding of consumer choices and preferences as an area of interest.

“Not all that’s broken in our health care system can be fixed legislatively. Sometimes it requires private sector action and intervention,” said Eileen McAnneny, Coalition Co-Chair and President of the Massachusetts Taxpayers Foundation. “The best way to effectuate change in the health

care marketplace, particularly for the commercially insured, is to help educate consumers and better inform them on the consequences of their choices.”

The Employer Coalition is supported by the Massachusetts Health Policy Commission (HPC). David Seltz, HPC Executive Director and Coalition Strategic Partner, announced at the meeting that the HPC would partner with the state’s Center for Health Information and Analysis later this year to field a survey related to consumer awareness of alternative care site options and costs.

“Employers can be a powerful voice in creating change,” said Seltz. “Even beyond the stated goal of the Coalition, this effort can serve as proof of concept that an employer-led, multi-stakeholder group can create change and move the dial.”

Over the next few months, the MEHC Steering Committee will develop an agenda consisting of proven strategies to reduce unnecessary emergency department use. Stakeholder workgroups, MEHC members, and strategic partners will help refine these strategies. This summer, MEHC Employer Members and Strategic Partners will support their members in committing to implementing one or more of the identified strategies.
